Q: WHAT ARE THE DESTINATION AND DATES FOR PASSPORT 2020?

A: Passport 2020 will take place at the Barceló Bávaro Grand Resort in Punta Cana, Dominican Republic on November 4 – 7, 2020.

Q: WHO CAN PARTICIPATE IN PASSPORT 2020?

A: Qualification is open to all MONAT Market Partners in the U.S., Canada, the UK, Ireland and Poland.

Q: WHAT IS THE QUALIFICATION PERIOD?

A: February 1, 2020 through July 31, 2020.

Q: HOW CAN I QUALIFY FOR PASSPORT 2020?

A: Market Partners will qualify by meeting the requirements listed below between February 1, 2020 and July 31, 2020:

Note:

- Your Personally Sponsored MPs and VIPs count toward your Personal Group Sponsor totals, including those beyond the minimum Personal Sponsor qualification.

- Any existing MMB career title or higher at the beginning of the qualification period in your downline will not count toward your qualification requirements. If the MMB or higher is demoted during the qualification period, they will count for: personal group, commissions and rank purposes, but will not count for the Passport incentive.

- In the event a new MMB career title or higher promotes in your personal group during the qualification period their results will be included in your qualification requirements the month they promoted and each month remaining of the qualification period.

Q: WHAT IS A PERSONAL GROUP?

A: Personal Group: A Market Partner and their entire downline, down to but not including the next MMB (career title) or higher.

Q: WHAT IS INCLUDED IN THE TRIP?

Qualifiers receive round-trip coach class airfare from their home airport to Punta Cana, Dominican Republic and accommodations for three nights. All trip earners' accommodations will include the resort's all-inclusive stay package.

Q: WHAT IS NOT INCLUDED IN THE TRIP?

- Ground Transportation
- Room Service
- Any excursions or activities not expressly noted in trip inclusions
- Incidental travel expenses
- Parking or transportation to originating airport
- Childcare / sitters
- Meals not expressly noted as part of the all-inclusive package offered by resort
- Meals and incidental expenses while in transit
- Baggage fees, change fees, premium or assigned seating costs
- Costs associated with travel delays, missed connections, weather events, or other disruptions in travel, including but not limited to overnight lodging in the cases of missed connections, canceled flights, early departures, negligence, and personal circumstances
- Trip Insurance

Q: CAN I BRING MY SPOUSE?

A: It depends. All qualifying Market Partner who meet the qualification criteria for Tiers 2 and 3 listed above, can bring a spouse and MONAT will pay for that spouse's airfare and lodging. Qualifiers meeting Tier 1 will not have the option of bringing a spouse, and will share a hotel room with another Tier 1-qualifying Market Partner.

Q: IF I EARN THE TRIP, BUT CAN'T GO, CAN I RECEIVE A SUBSTITUTE REWARD OR ALLOW SOMEONE TO GO IN MY PLACE?

A: No. Only the qualifying Market Partner can participate in this trip. No substitutions nor cash equivalents will be awarded.

Q: WILL THERE BE A PASSPORT 2020: DOMINICAN REPUBLIC PROGRESS TRACKER IN THE BACK OFFICE?

A: Yes. The tracker will go live by the end of February 2020.

Q: IS THIS INCENTIVE INCLUDED IN MY YEAR END TOTALS FOR TAX PURPOSES?

A: Yes, the value of the trip will be included in your T4A.

Q: DOES A VIP REFERRED BY ONE OF MY VIPS COUNT TOWARD MY QUALIFICATION?

A: Yes, VIPs under VIPs count toward qualification.

Q: WHAT IF MY VIP WHO REFERRED VIPS UPGRADES? WHO GETS THE REFERRED VIPS?

A: The VIP who upgrades will get the VIPs they referred, because they enrolled under the original VIP. This is our standard upgrade policy.
