Q: WHAT ARE THE DATES FOR REUNION EUROPE 2022?

A: Reunion Europe 2022 will take place in May 2022.

Q: WHO IS ELIGIBLE FOR REUNION EUROPE 2022?

A: All Market Partners in the UK, Ireland, Poland, Spain and Lithuania are eligible for Reunion Europe 2022.

Q: WHEN IS THE QUALIFICATION PERIOD?

A: The qualification period is 1st August 2021 through to 31st January 2022.

A: Since your qualification is based on your rank as of 1st August nothing changes; you must reach the required PV according to the rank with which you started the qualification, in this case MMP.
