

# MONAT Reunion 2023 May 2023

FAQ for Market Partners in the UK and Ireland

**Q: WHAT ARE THE DATES FOR REUNION EUROPE 2023?**

A: Reunion Europe 2023 will take place in May 2023 (save the date 1-4th May TBC)

**Q: WHO IS ELIGIBLE FOR REUNION EUROPE 2023?**

A: All Market Partners in the UK, Ireland, Poland, Spain and Lithuania are eligible for Reunion Europe 2023

**Q: WHEN IS THE QUALIFICATION PERIOD?**

A: The qualification period is 1st August 2022 through 31st January 2023.

**Q: HOW DO I QUALIFY FOR REUNION EUROPE 2023?**

A: Enrol 5 New VIPs with at least 100 PV within the qualification period AND meet the PV Requirement outlined below.

<b>VIP Enrolment Requirement (all tiers, all ranks)</b> Enrol 5 or more New VIP Customers (with 100+ PV in total purchases) during the 6-month qualification period *Minimum 1,000 PV must be from customer purchases each month (VIP or Retail) **Minimum 1,500 PV must be from customer purchases each month (VIP or Retail)

<b>All Market Partners must be paid-as MMP or above in January 2023 to qualify.</b>			

**Special promotion: AUGUST IS AUTOMATIC**

1st – 31st August 2022

**DOUBLE Your First Month:** Any Market Partner who achieves a Personal Volume (PV) of 1,500 or more in August will AUTOMATICALLY receive a second month counted toward their Tier 1 qualification.

**New Market Partners:** Any new Market Partners who enrol with any Product Pack in August will AUTOMATICALLY achieve their first month of Tier 1 qualification—worth 1,500 PV. Additionally, we’ll count a second month for those who achieve more than 1,500 PV on their starting month.

**Q: WHAT HAPPENS IF I CAREER RANK MANAGING MARKET PARTNER AS OF 1st AUGUST AND IN SEPTEMBER, I REACH MANAGING MARKET BUILDER?**

A: Since your qualification is based on your rank as of 1st August 2022, nothing changes; you must reach the required PV according to the rank with which you started the qualification, in this case MMP.

**Q. DOES THE NEW VIP HAVE TO PLACE AN INITIAL ORDER WITH 100 PV TO COUNT AS ONE OF THE 5 REQUIRED VIPs?**

A: No. The PV will be accumulative throughout the qualification period.

**Q. IF A NEW VIP RETURNS AN ITEM WILL THAT COUNT AGAINST MY PV TOTAL?**

A. Yes. The return amount will be deducted and count against the 100 PV requirement.

**Q. IF A NEW VIP THAT ENROLLED AFTER 1st AUGUST 2022 UPGRADES TO A MARKET PARTNER WILL THEY COUNT AS PART OF MY REQUIRED 5 NEW VIPs?**

A. Yes, they will count as one of your required 5 VIPs as long as they had at least 100 PV prior to upgrading.

**Q: WHAT IS INCLUDED IN THE REUNION EUROPE 2023 TRIP?**

A: Round-trip travel from main airports in UK, Ireland, Poland, Spain and Lithuania\*

**Q: WHAT IS NOT INCLUDED IN THE TRIP?**

A: The following items are not included:

- Meals other than those specified
- Any excursions or activities in which you choose to participate
- Promotional items

**Q: IF I EARN THE TRIP BUT CAN'T GO, CAN I RECEIVE A SUBSTITUTE REWARD OR ALLOW SOMEONE TO GO IN MY PLACE?**

A: No. Only the trip earner can participate in this trip. No substitutions or cash equivalents will be awarded.

MONAT reserves the right to adjust event dates at any time.

**Q: MAY I BRING A GUEST?**

A: Only Reunion Europe 2023 Tier 3 qualifiers may bring their spouse or a non-Market Partner guest complimentary. Airfare and accommodations for spouses/non-Market Partner guests is included. All guests must be 18 years of age or older at the time of travel and cannot be current Market Partners.

**Q: CAN I BRING MY CHILD?**

A: Nursing infants 24 months or younger may attend with their registered parent. Other than nursing infants, attendees must be at least 18 years of age and registered with a badge to attend all any of the events.
