**Q: WHAT ARE THE TRAVEL DATES FOR THE TRIP?**

A: Passport 2026 will be held 5<sup>th</sup>-8<sup>th</sup> November 2026, at the Hilton Hawaiian Village Waikiki Beach Resort.

**Q: WHAT IS THE QUALIFICATION PERIOD?**

A: The qualification period is 1<sup>st</sup> January-30<sup>th</sup> June 2026.

**Q: WHO CAN PARTICIPATE IN PASSPORT 2026?**

A: Qualification is open to all MONAT Market Partners in the USA, Canada, Mexico, the UK, Ireland, Poland, Lithuania, Spain, France, Belgium, Germany, Austria, Australia, and New Zealand who are in good standing with MONAT at the time of the trip.

**Q: IF I BECOME A MARKET PARTNER DURING THE QUALIFICATION PERIOD, CAN I STILL QUALIFY FOR PASSPORT 2026?**

A: Qualification is open to all MONAT Market Partners regardless of enrolment date, as long as qualifications are met.

**Q: HOW DO I QUALIFY FOR PASSPORT 2026?**

A: There are 2 pathways Market Partners can qualify for Passport 2026. The Builder Pathway and the Seller Pathway both outlined below:

- Personally sponsored and Personal Group-sponsored Market Partners must enrol with a Product Pack to count toward qualification.
- Personally sponsored and Personal Group VIPs must have an initial order of £60/€75 or more, and have a Flexship scheduled for £60/€75 or more.

## JANUARY GV INCENTIVE

- Complete the **Power of 2 Mid-Month Requirement (1+4) by 15<sup>th</sup> January** and receive 5,000 GV\* towards your own Passport Requirements!
- Complete the **Power of 2 Full Month Requirement (2+8) by 15<sup>th</sup> January** and receive 10,000 GV\* towards your own Passport Requirements!

*\*GV is only added towards your own Passport Qualifications. GV will not be added for your upline organisation and will not be applied toward GV Rank Requirements.*

### Q: WHEN WILL THE GV BE ADDED TO MY PASSPORT TRACKER?

A: GV will be added to your tracker by 17<sup>th</sup> February 2026.

### January Power of 2 End-of-Month GV Incentive

Didn't hit the Power of 2 milestones by mid-month? You still have time to earn GV towards your Passport Qualifications through 31<sup>st</sup> January.

Here's how you can earn:

#### If you missed both Mid-Month and Full Month by 15<sup>th</sup> January:

Complete **Power of 2 Full Month (2+8) by 31st January** and earn **5,000 GV\*** toward your Passport Requirements.

#### If you completed Mid-Month (1+4) by 15<sup>th</sup> January:

Complete **Power of 2 Full Month (2+8) by 31st January** and earn an **additional 5,000 GV\*** — for a **total of 10,000 GV\***.

#### If you completed Full Month (2+8) by 15<sup>th</sup> January:

Complete **1+4** again by **31st January** and earn an **additional 5,000 GV\*** — for a **total of 15,000 GV\***. (Total 3 MPs and 12 VIPs by 31st January.)

#### If you completed Full Month (2+8) by 15<sup>th</sup> January:

Complete **Power of 2 Full Month (2+8)** again by **31st January** and earn an **additional 10,000 GV\*** — for a **total of 20,000 GV\***. (Total 4 MPs and 16 VIPs by 31st January.)

*\*GV is only added toward your own Passport Qualifications. GV will not be added for your upline organisation and will not be applied toward GV Rank Requirements.*

### Q: WHEN WILL THE GV BE ADDED TO MY PASSPORT TRACKER?

A: GV will be added to your tracker by 17th February 2026.

### **JANUARY SELLER PATHWAY INCENTIVE**

*Achieve 50,000 PV in January it will count as 2 months towards qualification!*

#### **Q: WHAT IS A PERSONAL GROUP?**

A: A Personal Group consists of a Market Partner and their entire downline, down to but not including the next career-title Managing Market Builder or higher.

#### **NOTE:**

- Your Personally Sponsored MPs and VIPs count toward your Personal Group Sponsor totals, including those beyond the minimum Personal Sponsor qualification.
- Any existing career-title Managing Market Builder (MMB) or higher in your downline at the beginning of the qualification period will **NOT** count toward your qualification requirements. If the MMB or higher is demoted during the qualification period, that MP will count for Group Volume, commissions, and rank purposes but not for the Passport 2026 incentive.
- In the event a new career-title MMB or higher promotes within your Personal Group during the qualification period, that Market Partner's results will continue to be included in your qualification requirements each month of the qualification period.

#### **Q: IF I ENROL A VIP CUSTOMER WHO THEN UPGRADES TO MARKET PARTNER, WILL THEY COUNT TOWARD MY PASSPORT QUALIFICATIONS?**

A: Yes, but how they are counted—whether as a VIP or Market Partner—depends on when the upgrade occurs.

Examples:

- If a VIP enrolls in January 2026 and then upgrades to Market Partner in January 2026, they count toward Passport qualifications as a Market Partner, and you will need to enrol an additional VIP for Passport.
- If a VIP enrolled PRIOR to January 2026 and upgrades to Market Partner in January–30<sup>th</sup> June 2026, they count toward your Passport qualifications as a Market Partner.
- If a VIP enrolls in January 2026 and then upgrades to Market Partner in July 2026, they count toward your Passport qualifications as a VIP.
- If a VIP enrolls in January 2026 and then upgrades to Market Partner after 15<sup>th</sup> February 2026, and before 30<sup>th</sup> June 2026, they will count as a VIP AND as a Market Partner toward your Passport qualifications.

**Q: WHAT IS THE LOCATION FOR THE TRIP?**

A: Hilton Hawaiian Village Waikiki Beach Resort.

**Q: WHAT IS INCLUDED IN THE TRIP?**

A:

- 3 nights at Hilton Hawaiian Village Waikiki Beach Resort
  - Program nights only: 5<sup>th</sup>, 6<sup>th</sup>, & 7<sup>th</sup> November 2026.
- Round-trip flight to Honolulu International Airport
- Half-Day Training Session
- Exclusive Recognition
- Some meals
  - Day 2: Continental breakfast & welcome reception
- Round-trip airport transfers at destination
  - Provided when arriving/departing on program dates of 5<sup>th</sup> Nov. and 8<sup>th</sup> Nov. only.
  - Provided between Honolulu International Airport (HNL) and Hilton Hawaiian Village only.
  - Ground transportation is included for MP qualifer and Tier 2 or 3 registered guest.

**Q: WHAT IS NOT INCLUDED IN THE TRIP?**

A:

- Spouse/Guest airfare for Tier 1 qualifiers
- Meals and incidental expenses while in transit
- Any excursions or activities not expressly noted in trip inclusions
- Incidental travel expenses
- Parking or transportation to originating airport
- Childcare/sitters
- Baggage fees, change fees, premium, or assigned seating costs
- Costs associated with travel delays, missed connections, weather events, or other disruptions in travel, including but not limited to overnight lodging in the case of missed connections, cancelled flights, early departures, negligence, and/or personal circumstances
- Trip insurance
- Permits, visas, vaccinations, applications, or travel document fees needed for any portion of your journey to trip destination.

**Q: MAY I BRING A SPOUSE OR GUEST?**

A: Yes. Guest eligibility, inclusions, and costs vary by tier.

**Tier 1**

- May bring one non-Market Partner adult guest to share hotel accommodations.

- \$499 USD non-refundable guest registration fee required at registration.
- Guest fee includes: shared hotel accommodations, round-trip airport transfers at destination, guest name badge, and access to the Welcome Reception.
- Not included: airfare, onsite swag, gifts, or any Market Partner-only inclusions.
- Guests under 18 may share hotel accommodations per hotel policy but may not attend official events requiring credentials.

#### **Tier 2**

- May bring one adult, non-Market Partner guest.
- Guest registration fee is waived for Tier 2 qualifiers.
- Includes shared hotel and select meals for the earning Market Partner and one adult, non-Market Partner guest.
- Guest airfare is not included.
- Guest must be registered at the same time as the Market Partner.

#### **Tier 3**

- May bring one adult, non-Market Partner guest.
- Guest registration fee is waived for Tier 3 qualifiers.
- Includes airfare, shared hotel, and select meals for the earning Market Partner and one adult, non-Market Partner guest.
- Guest must be registered at the same time as the Market Partner.

#### **Guest Requirements (All Tiers)**

- Guests must be at least 18 years of age at the time of travel (unless otherwise noted above).
- Guests may not be an active Market Partner (excluding named, joint MPIDs), minor (for event access), or otherwise excluded under MONAT Terms and Conditions.
- Guests must travel on the same flight itinerary as the earning Market Partner.

#### **Q: WHAT HAPPENS IF I EARN THE TRIP, REGISTER, AND DO NOT ATTEND?**

A: If you register for Passport and do not attend you will be subject to a \$1,000 USD fine from MONAT to cover the <cancelation> cost of the trip, subject to case-by-case review.

#### **Q: IF I EARN THE TRIP BUT CAN'T GO, MAY I RECEIVE A SUBSTITUTE REWARD OR ALLOW SOMEONE ELSE TO GO IN MY PLACE?**

A: No. Only qualifying Market Partners may participate in this trip. No substitutions or cash equivalents will be awarded.

#### **Q: IF I EARN THE TRIP, MAY I BRING MY CHILDREN?**

A: Should you choose to bring a child to Passport 2026:

- Children are not permitted to attend any of the MONAT planned sessions, reception, or activities.
- The cost of additional guest room occupancy is your sole responsibility and, if applicable, will be collected directly by the hotel upon check in.
- All travel costs, including airfare and ground transportation are the responsibility of the trip earner.
- Compliance with all laws of regulations related to international travel of minors are the traveller's sole responsibility.

#### **Q: AM I RESPONSIBLE FOR INCOME TAX ATTRIBUTABLE FOR THIS TRIP?**

A: Qualifiers attending Passport 2026 will be solely responsible for income taxes attributable to the non-cash compensation as a result of MONAT paying for incentive trips and other non-cash awards. In certain instances, the value of this incentive trip may be reported to the tax authorities in your jurisdiction in accordance with the country's applicable tax law.

**If and where applicable, any hotel or airfare paid by MONAT will be reported to respective tax authorities.**

Qualified Market Partners who register for an event and do not or cannot attend will remain responsible for the taxable value of any non-refundable costs incurred by MONAT. Examples of taxable trip value that will remain reportable even when a Market Partner is unable to attend would include: a minimum of one-night's room rate, hotel taxes, and resort fees. Non-refundable airfare paid by MONAT will be included in taxable income reporting where applicable as defined by your country's taxation guidelines at the time of this trip.

**Q: WHEN WILL THE OFFICIAL PASSPORT 2026 QUALIFIER LIST BE ANNOUNCED?**

A: Qualifications for Passport 2026 end 30<sup>th</sup> June and the official qualifier list will be announced in July 2026.

*Please note that all trip qualifications are subject to Compliance review for potential bonus buying and rank advancement manipulation. Any purchases or enrolments not in compliance with MONAT Policies and Procedures will be deemed ineligible and bonuses will not be paid. Additionally, any violation of MONAT Policies and Procedures may render a Market Partner ineligible to participate in the programme and may result in further compliance action to the Market Partner's account, including and up to account suspension or termination.*
