Q: WHAT ARE THE DATES FOR MONAT ELITE 2019: BARCELONA & MONTE CARLO?

A: Trip dates are May 20 – 27 as follows:

- May 20: Overnight flights to Barcelona, Spain
- May 21 – 23: Barcelona, Spain
- May 24: Private Air to Nice, France
- May 24 – 26: Monte Carlo, Monaco
- May 27: Return flights from Nice, France

Q: WHO IS ELIGIBLE FOR MONAT ELITE 2019: BARCELONA & MONTE CARLO?

A: All Directors in the U.S., Canada and the U.K. are eligible for the trip.

Q: WHAT IS THE QUALIFICATION PERIOD?

A: September 1, 2018, through January 31, 2019.

Q: WHAT IS INCLUDED IN THE MONAT ELITE 2019: BARCELONA & MONTE CARLO?

- 3 Nights of Luxury Accommodations in Barcelona, Spain.
 - 2 Nights of Luxury Accommodations in Monte Carlo, Monaco.
 - Round Trip Premium Airfare and Accommodations for You and Your Spouse/Significant Other.
 - All Ground Transfers.
 - First Class Excursions.
 - MONAT Style Surprises.

Q: HOW CAN I QUALIFY FOR MONAT ELITE 2019: BARCELONA & MONTE CARLO?

A: No. Only the trip earner can participate in this trip. No substitutions nor cash equivalents will be awarded. MONAT reserves the right to adjust event dates at any time.

- Qualification Period: 9/1/18-1/31/19
- To Qualify, Must have achieved Director rank by 9/1/18
- Promote a Market Partner in your Personal Group to AED. Or, promote a current (as of Sept. 1, 2018) Director who is direct to you to a new Director rank—an AED to ED or an ED to SED.
- The 10 trip qualifiers will be decided based on the number of Directors promoted (either to AED, ED, or SED, as explained above).
- Ties will be broken by the number of Blocks built by the Director during the promotion period. Each element of the Block (four VIPs and a Market Partner with a Product Pack) must be enrolled within a calendar month to be counted.
- In other words, four VIPs and an MP with a Product Pack enrolled October 31 through November 29 does not count as a Block. But, the same five elements enrolled November 1 through November 30 does count as a Block.

Q: WHAT IS MY PERSONAL GROUP?

A: Your Personal Group includes you and all Market Partners below you down to, but not including, other Directors and their legs. For example, assume in one leg there is a Director on your 7th level. For that leg, all Market Partners on levels one through six are in your Personal Group. Promote someone from those levels to a Director rank to qualify.

Q: DO I NEED A PASSPORT? DO I NEED VISAS?

A: Yes, a passport is required for international travel. Visa needs will depend on which government issues your passport. For U.S. and Canadian citizens, visas will not be needed.

Q: WILL QUALIFIERS HAVE THE OPTION OF ADDING ON DATES, EITHER BEFORE OR AFTER THE PROGRAM DATES?

A: Yes. Any incremental expenses would be the responsibility of the qualifying Market Partner.

Q: IF I EARN THE TRIP, BUT CAN'T GO, CAN I RECEIVE A SUBSTITUTE REWARD OR ALLOW SOMEONE TO GO IN MY PLACE?

A: No. Only the trip earner can participate in this trip. No substitutions nor cash equivalents will be awarded. MONAT reserves the right to adjust event dates at any time.
