**Q: WHAT ARE THE DATES FOR REUNION 2021 LAS VEGAS?**

A: **Announced February 22, 2021:** Qualifiers may now opt to attend either April 12-15, 2021 or July 5-8, 2021.

**Q: WHO IS ELIGIBLE FOR REUNION 2021 LAS VEGAS?**

A: All Market Partners in the USA and Canada are eligible for Reunion 2021 Las Vegas.

**Q: WHEN IS THE QUALIFICATION PERIOD FOR REUNION 2021 LAS VEGAS?**

A: The qualification period is August 1, 2020 through January 31, 2021.

**Q: HOW DO I QUALIFY FOR REUNION 2021 LAS VEGAS?**

All Market Partners must be paid-as MMP or above in January 2021 to qualify.

**Special promotion for August:**

All new Market Partners who join MONAT with a Product Pack in August will get the first month of Reunion 2021 Las Vegas requirements on us. That's worth 1,200 PV! Market Partners enrolled before August 1, 2020 who achieved their first month of qualification toward any of the 3 tiers in August AUTOMATICALLY receive a second month counted toward that same tier!

**Q: WHAT HAPPENS IF I CAREER RANK MANAGING MARKET PARTNER AS OF AUGUST 1, AND IN SEPTEMBER I REACH MANAGING MARKET BUILDER?**

A: Since your qualification is based on your rank as of August 1, nothing changes; you must reach the required PV according to the rank with which you started the qualification, in this case MMP.

**Q: WHAT IS INCLUDED IN THE REUNION 2021 LAS VEGAS TRIP? – Updated February 22, 2021**

- A:
- Roundtrip, coach class airline ticket to Las Vegas McCarran International airport (LAS)
  - Three-night hotel accommodations
  - Swag
  - A \$300 food & beverage credit (Tier 2 and Tier 3 only)

**Q: WHAT IS NOT INCLUDED IN THE TRIP?**

- A: The following items are not included:
- Ground transportation
  - Meals
  - Any excursions or activities in which you choose to participate
  - Promotional items

**Q: IF I EARN THE TRIP BUT CANNOT GO, CAN I RECEIVE A SUBSTITUTE REWARD OR ALLOW SOMEONE TO GO IN MY PLACE?**

A: No. Only the qualifier can participate in this trip. No substitutions or cash equivalents will be awarded. MONAT reserves the right to adjust event dates at any time.

**Q: WHAT HAPPENS IF I EARNED THE REUNION 2020 TRIP, ELECTED TO DEFER TO ATTEND REUNION 2021, AND ALSO QUALIFY FOR REUNION 2021?**

A: You automatically qualify for Reunion 2021! If you deferred your MONAT Reunion 2020 qualification to MONAT Reunion 2021 dates, you receive the same Tier award you earned in 2020. **PLUS:** If you qualify for Reunion 2021, you'll receive a cash award to enhance your Reunion experience, as follows:

**Updated February 22, 2021**

**Q: WHAT HAPPENS IF I DEFERRED FROM 2020 TO 2021 AND OPT NOT TO TRAVEL IN 2021—WILL I RECEIVE MY CASH AWARD?**

A: All Reunion 2020 trip inclusions and/or value, including food & beverage credits, and cash awards are forfeit. No alternative compensation, trip dates, or further options are available for the 2020 and/or 2021 performance for MPs who cannot or choose not to travel on either date option provided in 2021.

**Q: HOW WILL THE CASH AWARD BE PAID?**

A: MPs who qualified for Reunion 2020 and are eligible to receive the cash award promotion will receive this payment in the same month they elect to travel for Reunion 2021. MPs must attend Reunion 2021 to receive their cash award.

**Q: WHEN WILL THE CASH AWARD BE PAID?**

A: All cash awards will be paid based on the elected travel dates and will be disbursed on a date determined by MONAT.
