FAQ FOR MARKET PARTNERS IN THE USA

Q: WHAT ARE THE TRAVEL DATES FOR THE TRIP?

A: Passport 2021 will be held October 21–25, 2021, at the Barceló Bávaro Resorts in Punta Cana, Dominican Republic.

Q: WHAT IS THE QUALIFICATION PERIOD?

A: AUGUST 3, 2021 UPDATE: The qualification period has been extended for Market Partners (MPs) who did not qualify for Passport 2021 by July 31, 2021. Their qualification period is now February 1–August 31, 2021. All MPs who qualified by July 31, 2021, will maintain the qualification status they earned by that date.

Q: IF I QUALIFIED FOR PASSPORT 2021 BY JULY 31, 2021, CAN I USE THE MONTH OF AUGUST TO EARN A HIGHER TIER?

A: No. The August extension is only for MPs who did NOT qualify by July 31, 2021. MPs who qualified at Tiers 1 or 2 by that date may not use August to upgrade their tier status. They will travel at their July-qualified tier.

Q: WHO CAN PARTICIPATE IN PASSPORT 2021?

A: Qualification is open to all MONAT Market Partners in the US, Canada, the UK, Ireland, and Poland, who are in good standing with MONAT at the time of the trip.

Q: HOW DO I QUALIFY FOR PASSPORT 2021?

A: Market Partners can qualify by meeting the requirements listed in the chart below.

NOTE:

- Your Personally Sponsored MPs and VIPs count toward your Personal Group Sponsor totals, including those beyond the minimum Personal Sponsor qualification.
- Any existing career-title Managing Market Builder (MMB) or higher in your downline at the beginning of the qualification period will NOT count toward your qualification requirements. If the MMB or higher is demoted during the qualification period, that MP will count for: Personal Group, commissions, and rank purposes, but not for the Passport 2021 incentive.
- In the event a new career-title MMB or higher promotes within your Personal Group during the qualification period, that MP’s results are included in your qualification requirements on the month of promotion and each month of the qualification period.

Q: WHAT IS A PERSONAL GROUP?

A: A Personal Group consists of a Market Partner and their entire downline, down to but not including the next career-title Managing Market Builder or higher.

Q: WHAT IS THE LOCATION FOR THE TRIP?

A: Barceló Bávaro Palace and Barceló Bávaro Beach Resort in Punta Cana, Dominican Republic.

Q: WHAT IS INCLUDED IN THE TRIP?

A: Qualifiers receive round-trip airfare from their home airport to Punta Cana, Dominican Republic, and accommodations for four nights. All trip earners' accommodations will include the resort's all-inclusive stay package. Details can be found [here](#).

Q: WHAT IS NOT INCLUDED IN THE TRIP?

- Ground transportation
- Spouse attendance for Tier 1 qualifiers*
- Room service
- Any excursions or activities not expressly noted in trip inclusions
- Incidental travel expenses
- Parking or transportation to originating airport
- Childcare/Sitters
- Meals not expressly noted as part of the all-inclusive package offered by resort
- Meals and incidental expenses while in transit
- Baggage fees, change fees, premium, or assigned seating costs
- Costs associated with travel delays, missed connections, weather events, or other disruptions in travel, including but not limited to overnight lodging in the case of missed connections, canceled flights, early departures, negligence, and/or personal circumstances
- Trip insurance

*A spouse/non-Market Partner guest is allowed for Tier 1 earners if that option is selected and paid for during registration. Subject to availability and a \$499 fee.

Q: CAN I BRING MY SPOUSE?

A: Market Partners who meet the qualification criteria for Tiers 2 and 3, as listed above, can bring a spouse and MONAT will pay for that spouse's airfare and lodging. Tier 1 qualifiers have the option to pay for a non-Market Partner guest travel during registration.

Q: IF I QUALIFIED AS TIER 2 OR 3, WHAT IS THE COST OF BRINGING A GUEST?

A: Tier 2 and 3 qualifiers may bring a guest as part of their qualification award.

Q: IF I QUALIFIED AS TIER 1, CAN I BRING A GUEST?

A: Tier 1 will now have the option to bring a non-Market Partner guest for a non-refundable \$499.00 fee. This cost does not include airfare, transfers, and some company-sponsored events and is subject to availability.

Q: IF I QUALIFIED AS TIER 1, CAN I CHOOSE MY ROOMMATE?

A: Yes! We will do our best to honor roommate requests. Tier 1 qualifiers will be roomed together based upon country, region, and by teams. We do not guarantee single-occupancy rooms, nor will we be able to confirm anyone for single rooms.

Q: IF I EARN THE TRIP, BUT CAN'T GO, CAN I RECEIVE A SUBSTITUTE REWARD OR ALLOW SOMEONE ELSE TO GO IN MY PLACE?

A: No. Only qualifying Market Partners can participate in this trip. No substitutions or cash equivalents will be awarded.

Q: WHAT ARE THE TAX IMPLICATIONS OF PARTICIPATION IN TRIPS OR PRIZES I RECEIVE FROM MONAT?

A: You (the Market Partner) accept sole responsibility and agree to pay all federal, state, provincial, and local taxes on the value of trips, prizes, or awards you accept from MONAT, as required by the laws in your country of residence, and further agree to indemnify MONAT from any failure to pay such tax amounts when due.
