

# DREAM BIGGER GIVEAWAY

**Q: WHAT IS THE DREAM BIGGER GIVEAWAY?**

A: The Dream Bigger Giveaway is a drawing during the Dream Bigger Spectacular at ELECTRIFY MONATIONS United 2022. A Grand Total of \$100,000 USD will be given away.

- Five in-person attendees will win \$20,000 USD each. Attendees must be present at the Dream Bigger Spectacular to claim their prize.

**Q: WHO IS ELIGIBLE FOR THE DREAM BIGGER GIVEAWAY?**

A: MONAT Market Partners who have registered to attend MONATIONS and are in good standing and of legal age at the time of entry. Attendees must be present at the Dream Bigger Spectacular to claim their prize.

**Q: HOW DO I ENTER THE DREAM BIGGER GIVEAWAY?**
